NEW VOK Library Board



One (1) two-year term due to expire May 2022; Two (2) three-year terms due to expire May 2023. This board meets once per month consistently on the 3rd Tuesday. Joint Police Commission



One (1) three-year term due to expire May 2023 , This board meets regularly around 4 times per year depending on hiring and recruiting efforts for staffing the Fox Valley Metro Police Department. Why join? The Fox Valley Metro Police Commission is responsible for the review of the operations of the Fox Valley Metro Police Department. Their duties include the authority to hire, discharge, and discipline employees as provided in Sec. 62.13(5) and (6) Wis. Stats. and shall be responsible for policy and procedures pertaining to promotions and discipline. The Commission does not maintain optional powers as defined by Sec. 62.13(6) Wis. Stats. Responsibilities include appointing the Police Chief; conducting original entrance examinations at the lowest ranks and preparing the eligibility list; conducting examinations for specialized positions when necessary and conducting hearings on discharge or disciplinary actions. Board of Appeals



Two (2) three-year terms due to expire May 2023; Two (2) alternate member terms due to expire May 2021. This board meets on an as needed basis (typically no more than 6 meetings per year) . Reviews requests for variances to the Zoning Code; hears and decides appeals of alleged error in any order, decision, determination or requirement in the enforcement of the Village Zoning Code or ordinances adopted with regard to state statutes concerning wetlands, floodplains or farmland preservation. Community Development Authority

One (1) four-year terms due to expire April 2024. The CDA helps to drive the vision for the community and discuss revitalization of downtown areas and the vision for the riverfront development. The CDA has the power, duties and functions conferred on redevelopment, housing and community development authorities by applicable state law. It is responsible for carrying out blight elimination, clearing undesirable conditions, urban renewal programs and projects and housing projects within the Village. Fire Commission



One (1) five-year term due to expire May 2025. The Kimberly Fire Commission meets approximately 4 times throughout the year to discuss staffing, hiring, and recruiting for the fire department. The Fire Commission will conduct original entrance examinations, conduct examinations for specialized positions, conduct hearings on discharge or disciplinary actions and conduct all of its business and follow the rules and regulations in accordance with and as prescribed by Wisconsin Statutes regulating fire commissions. Plan Commission



One (3) three-year term due to expire May 2023. This commission meets the third Tuesday of each month. This commission completes site reviews, ordinance changes, and approves conditional use permits. The Plan Commission's role is to promote the orderly growth and development of the village in a manner intended to maintain a high-quality living environment in the most efficient and cost-effective manner. The Village Board tasks the Commission with making reports and recommendations relating to the development of the village. In essence, nothing gets built in the Village without the Plan Commission having a say. Appointment to this commission is compensated. Sex Offender Residence Board

One (1) five-year term due to expire May 2025. This board only meets upon request of applicants interested in living in Kimberly. (approximately 1-2 times per year) This board hears the request of the applicant, listens to feedback from Fox Valley Metro Police Department concerning any current applicants and previously approved applicants, and provides overall monitoring and review of offenders within Kimberly. Tree Board



One (1) three-year term due to expire May 2023. This board meets on an as needed basis to make amendments to the village tree ordinance and guide the village in future efforts to enhance and diversify the tree canopy in Kimberly especially as it relates to the village's Tree City USA designation. Meetings are held no more than 2-3 times per year.
