A Winter to Learn from and Forget...

As I write, the morning sneezes indicate trees budding out, tulips bringing color to neighborhood landscapes and sure signs that winter is behind us; oh, and what a winter it was! I am not one that likes to dwell on the past, however I see great value in being stewards of history in planning for the future. The winter obstacles we faced will be used as learning events for future snow and ice management. No doubt, the combinations of snow, wind, rain and sleet created conditions that were difficult to tackle as the crew worked to present clean and safe passable streets. Leave no doubt, the effort was there; the curves tossed didn't help us to align effort with desired results. Rain and sub-zero temps render salt useless. Frozen piles of slush are not easily tossed by a giant snow blower which left the Avenue narrower than ever desired after the unit was made inoperable with broken parts. Lessons learned and plans made. The Village of Kimberly continues to focus on priorities of safety, streets, sewers and self. This year the team learned many valuable lessons to make next winter a smoother ride in the VOK!

On a brighter note, spring is announced once again with our Arbor Day celebration as this year, students from Westside under the guidance of tree expert Lee Hammen spruced up Van Daalwyk Park planting some fifty white cedars and learning the value of trees to the community. A breezy day, but fruitful for sure as we accepted recognition from the DNR once again as a Tree City USA. As we were presented the Tree City USA Flag which will be flown at Westside, the DNR representative shared with me his discovery of the dreaded Emerald Ash Borer; yes, that put a damper on the day! We have been monitoring the spread of the borer as its presence was well documented in Appleton and working its way east. You may have noticed some more aggressive action in removal of trees throughout the village as we try to keep the invasive pests at bay. Please know that we will continue to be aggressive in not allowing for infestation and we will replant just as soon as our annual tree budget allows.

It is that time of year as well to remind everyone of the Sunday at the Amphitheatre programming, community band concerts, availability of swim lake passes and a host of recreation opportunities that we encourage everyone to partake in and enjoy as much of the spring, summer and fall as you can!

The board continues to meet most Mondays in discussing an array of topics ranging from chickens to riverfront development. You are encouraged to join in the conversations. I am happy to share that on the development docket, we have seen great movement and the areas north of Maes will have a whole new look come fall. Treaty Park should see 60% completion, the "Big Blue" buildings near the bridge are slated for demolition in August/September, the main mill building will be reduced between now and fall as well as developers determine how to build up from its existing foundation. Cedars roadways are being paved as I write and Papermill Run will be improved with grading and graveling this summer. The area west should see even more activity as the weather warms. We have eager developers locked in to make River's Edge subdivision a real jewel in this redevelopment. The Midwest Expansion projects along the river are adding something unique and highly sought after. Their aggressive plans call for Ebb and Oasis to be ready yet this fall! Please be safely curious when watching these areas grow.

I will close with words of congratulations to the Village Administrator, Dani Block. Dani was honored with the Steven Hintz Award at UW-Oshkosh in recognition of her work in the Master's Degree Program and her commitment to Municipal Excellence. We are proud and thankful for her efforts and commitment to running the show and keeping Kimberly a great place to live, learn, work and play!

BULKY/LARGE ITEM COLLECTION SCHEDULE

Other reminders: Bulky Items are *not to be placed on the Street Terrace for collection any earlier than 5 pm the day before the regular collection time* per Village Ordinance 418-6 B.

Village Ordinance section 418-6 D. Collection of Bulky Items provides guidance on the types of materials to be collected with this program, as well as materials not intended to be collected: **Bulky Items** as defined in the Village Ordinance includes large, bulky, nonmetal items such as sofas, mattresses, chairs, toilets, non-metal furniture, carpeting (cut, rolled, and tied in sections not exceeding 4 feet) and other similar items. **Bulky Items** do not include materials such as dirt, stone, concrete, plaster, and all other building materials.

Placement for Collection. Items qualifying for collection shall be placed neatly and orderly on the street terrace, behind the curb for collection.

Voter Registration

If you are a new voter or have moved or changed your name, you must register to vote. Update your voter registration at least 20 days before an election in order to be pre-printed in the regular poll book. Complete the paperwork at the Village Clerk's Office or online using www.myvote.wi.gov. You will need proof of residency that states your current name and address; such as WI Driver's License/ID, utility bill, bank statement, credit card statement, pay stub or government document. Please contact the Clerk's Office if you need assistance. **There are NO additional Elections scheduled for 2019.**

Hiring Election Workers

The year 2020 will be a big year for Elections and the Village of Kimberly needs YOU!!!! We are looking to hire outgoing people who are interested in assisting voters during the absentee voting period before each election and at the Polls on Election Day. We provide training and you get to choose your availability for each election (so even snow birds are welcome to apply as we need coverage year round). Positions are available for seated work and standing so don't let that hold you back from applying if you need accommodations. Election workers often comment on how much fun they have working together to serve the voters. Policy for Wait List for "Class B" Intoxicating Liquor Licenses

Waiting List

1. If the Village has met its quota on the issuance of "Class B" Intoxicating Liquor Licenses, a waiting list of those persons wishing to obtain a "Class B" Intoxicating Liquor License will be established. The names will be added to the list in the order that the written requests are received. Written requests should be directed to the Clerk at the Village Hall Office. The request should include the name, company or corporation, phone number and the proposed address of the establishment, if known.
2. This list shall be updated every year in June. It shall be the responsibility of the requestor to resubmit a written request each year in May, indicating their desire to remain on the waiting list.
3. If a license becomes available, the first person on the list will be notified and given 10 business days to submit a Liquor License application. If they do not respond within the 10 business days, the next person on the list shall be notified.

KEY CLUB reminder:

With Prom season upon us, and graduation a hop, skip, and a jump away, students are getting excited for new experiences. This is a season of CELEBRATION! The hard work of the school year is fading, and there is plenty of partying to be had. Still, new and exciting experiences often include risk and danger.

This time of the year teens ranging from sixteen to eighteen are at a high risk for car accidents--and not just because of alcohol. Teens' lack of experience and overconfidence behind the wheel result in them being the group most prone to distracted driving. This means that teens between sixteen and twenty are three times more likely to die in car crashes than drivers over twenty years old.

Newsline 360 remind parents, "it's important to recognize teens are at increased risk for car accidents, whether they drink or not. To protect your teen on prom night or graduation, create a game plan for both events. If you can, keep your teen off the road altogether by hiring a limo, playing chauffeur yourself, or ordering a ride share. If that's not possible, remind your teen of the "house" rules for driving: seatbelts are not optional, phones are not to be used while driving, and no amount of alcohol is okay. Add credit to your child's Uber or Lyft account to make it easier to choose a safe option -- and remind your child that you'll provide a no-questions-asked pick up any time, anywhere if your child is in an unsafe situation."

These nights which begin in fun and lighthearted pleasure, can just as quickly turn into life-altering, non-rewindable, horrific new realities.

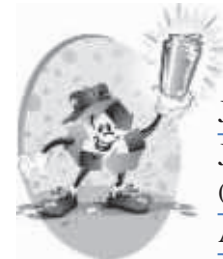

LAWN HEIGHT & WEED NOTICE

Pursuant to the Village of Kimberly Code of Ordinances, notice is hereby given to each person who owns, occupies, or controls land in the Village of Kimberly, Outagamie County, State of Wisconsin, to destroy all noxious weeds and to cut or remove the accumulation or growth of weeds, grass, brush, or other rank or offensive vegetation which has grown to a height greater than eight (8) inches.

A minimum of one hour will be charged to cut noxious weeds or grass 8" or longer at \$75.00 per hour plus equipment usage and administrative fee.

NEWLY PLANTED TREE CARE

New trees, which will be planted throughout the Village, need care. Please water these trees with *Five (5) gallons* every 4 to 5 days during dry spells.

When mowing and trimming around trees, please avoid hitting the base of the tree. There are quite a few terrace trees with bark torn from the base due to mowing and trimming too close to the tree. If this occurs too often, there is a good chance the tree will die. When a terrace tree dies, the replacement time could take up to 5 years, due to commitments in other areas of the community.

WARNING

DO NOT PLACE YARD WASTE OR RECYCLING IN YOUR REGULAR GARBAGE!!

In an effort to reduce organic waste and recycling in the landfill, Outagamie County has started to inspect the loads of garbage our drivers dump in the landfill. The Village will be issued a citation if grass clippings, yard waste, other organic materials, or recycling is found in our loads.

Our drivers will be keeping a closer eye on the hopper camera. Yes there is a camera in each of the automated garbage trucks so that they can see what is being dumped in the truck. If they detect any yard waste, grass clippings, or recycling coming out of your cart it will be tagged, and a written warning will be sent to the owner of the property. Any further violations will result in a citation being issued.

GRASS CUTTING REMINDER

When cutting your lawn near the street, try to make your first two passes with the discharge chute directed away from the street. Grass can clog up storm sewer catch basins, which doesn't allow the street to drain properly. Water that drains from the street and into storm sewers ends up in the river, along with all the grass clippings. Grass clippings also hold fertilizer and pesticides that contaminate streams, rivers, and lakes. The DNR encourages leaving grass clippings on your lawn, as they can act as good nutrients, as well as composting your lawn clippings. Residents who blow grass clippings into the street are subject to a citation per ordinance 430-16, 430-17.

DOGS IN THE PARK A recent change to ordinance 372-1 allows for dog owners to apply for a pooch patrol permit to allow registered dogs to run at large to chase geese in certain areas in our parks. Any person without a pooch patrol permit is reminded that no person shall permit any dog, cat or other pet to run at large in any parks. Citations will be issued in the event you don't have your dog on a leash.

REMINDER Per Ordinance 180-10: The owner or person in charge of any dog, cat, horse or other animal shall not permit solid fecal matter of such animal to deposit on any street, alley or other public or private property unless such matter is immediately removed therefore by said owner or person in charge. This section shall not apply to a person who is visually or physically handicapped.

Educational Information

The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.

- In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.
