What's Going On?

In my role as village president, I hear the question often: What's going on at the mill site? What's going on with the Sunset park shelter? What's going on with the squad cars going by? What's going on with leaf pickup? What's going on with crossing guards? What's going on with fireworks this year? What's going on with the street lights in my neighborhood? What's going on with taxes? Yes, there are many things "going on" in our quaint Village of Kimberly.

Knowing full well that I will not hit on every curiosity, I will try to address a few of the questions I hear most often, beginning with: what's going on at the mill site? Development is what is going on at the mill site. Visible and inviting development which includes:

- Residential units by way of the Papermill Estates Planned Unit Development along Maes Avenue featuring owner occupied duplex living, town homes and single-family dwellings.
- North of this development you will find a new storm water management pond.
- Behind the Clubhouse are some parceled out lots for sale with great views.
- On the west end, we will be seeing single family residential homes being built.
- Lots along the Fox and surrounding the Cedars West Pond are being purchased and we expect building to be very active this spring!

President's POINT OF VIEW

- Along the river, you can see the rising from the ground, the first of three high end apartment communities named "Oasis". The entire complex called "The Current", built upon the water intake tank repurposed from mill operations will have top shelf amenities and provide a modern and attractive building that people will clamor to inhabit! This structure will be followed with the build out of its counterparts - "Ebb" and "Flow." You can see clearly now, the street layout in the development to navigate north, south, east and west. Papermill Run travels adjacent to the river, River's Edge winds along the west end, Red and White Cedars outline the footprint which will be seen to grow in to Treaty Park. Like a great puzzle, the pieces are connecting nicely. One "what's going on" that I hear often is in reference to the "tall building." While the upper portions of that property have little redevelopment value, the developer, Jeff Noelder and his family are exploring using the lower portions and its unique architecture in another build out after their three apartments are well under way. An exploratory dive crew recently went deep to record what is under the building and in the river to determine what can be done structurally. It is intriguing and exciting to await the "what ifs" on these buildings!

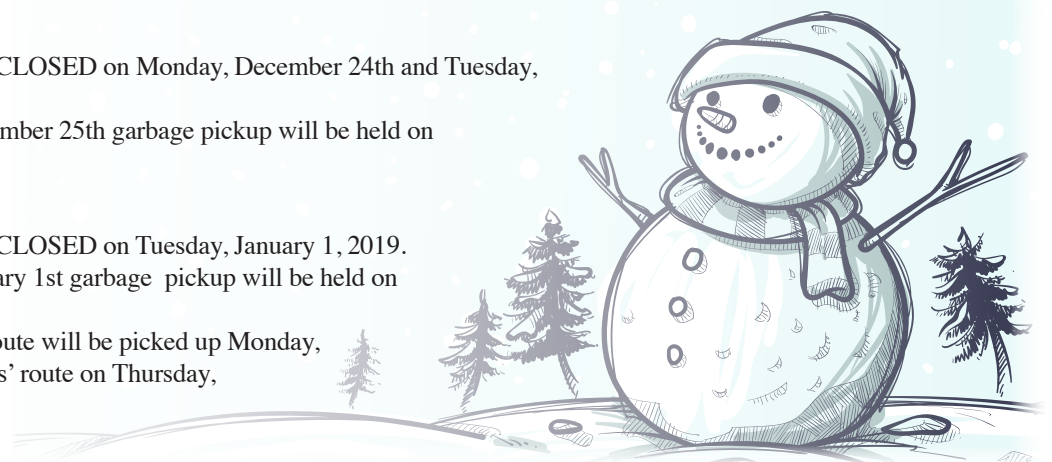

President's Letter continued...

What's happening with the #1 Picnic Shelter at Sunset Park is the Kimberly High School Construction class is rebuilding the structure! A hands-on learning experience began in September with the demolition of the sixty plus year old structure and the students are carefully building a much needed updated facility with many added amenities. This is the second project the class is tackling for the Village, as they completed the Gazebo at Memorial pond previously.

Fireworks planning was underway by our terrific volunteer fire fighting force before the last mortar exploded I believe! The car washes, bean bag toss tournament, reaching out to local businesses, and relentless efforts are a labor of love for this group. We truly are appreciative of their efforts.

Where is that squad car headed? Interesting question and one that has an answer that is difficult to clearly answer. Considering that the Fox Valley Metro handled 11,103 calls for service in 2017 and is on pace to repeat that; it is hard to pinpoint where, exactly they are headed. The calls range from felony arrests - there were 95 of them in 2017 and 94 through mid-October of this year, to 58 assaults, 17 burglaries, 101 larceny arrests, 3 robberies, and 7 car thefts. Add on the more than 4,000 interactions with people involved in accidents and vehicle violations, your Metro force is active every day! You may find it interesting to learn that the average time spent traveling to a call, investigating, or assisting at a scene is one hour and forty-three minutes! Followed by a mountain of paperwork that accompanies every contact. Interesting don't you agree?

Another "what" question that comes to me from time to time concerns the budget. What do we spend your (and my) tax dollars on? Some taken for granted items beyond the cost of policing, by far the biggest expense in the 5.6-million-dollar budget at 1.1 million, add a quarter million for fire protection, \$35,000 in salt to keep roads clear in the winter, \$5,200 to operate the traffic signal lights, \$1,450 to light the community bridge and \$145,000 to illuminate the neighborhood streets. We will contribute \$84,000 to have bus service travel through the village and we will pay \$88,000 to dump trash in the landfill. A portion goes to maintain an efficient fleet of vehicles to handle snow, leaves, grass cutting, and of course, the staff to operate the equipment. We will invest over \$170,000 in providing relevant library service and will maintain our Tree City USA status with a \$10,000 investment in additional trees in the coming year. I could write pages to explain the "what is the cost to maintain the village," but this is a snapshot of the 150-page budget document.

No matter the question, the answer will always be that whatever it is that the village team members are engaged in, it is focused on meeting the expectations of you and your neighbors. Safe streets, maintained roadways, quality of life offerings, dependable sewers, water delivery systems, and trash and recyclables handled properly. I hope you agree with my view that day in and day out, the investments made, and the efforts brought forth continue to maintain the Village of Kimberly as a great place to live, learn work and play.

You will need proof of residency that states your current name and current address – WI license/ID, utility bill, bank statement or credit card statement, or government document works best. Call if you need more options.

Need to vote absentee? Absentee Ballot Applications can be found at www.vokimberly.org or at www.myvote.wi.gov or by emailing jmicke@vokimberly.org. A copy of your photo ID must be included with your application for a ballot, if we DO NOT have it on file already. Apply early to ensure your ballot is sent and returned in time to be counted with our Election Day results!

STREET DEPARTMENT

Garbage & Recycling Reminders for Winter and the Upcoming Holidays

- Polycarts CANNOT be placed in the road or on top of snow piles
- The polycart MUST be placed at ground level either on the terrace or in the drive way. Polycarts which are placed in the road for pick up, during winter months, are subject to be plowed over and damaged. Replacement of damaged carts are the responsibility of the property owner at the cost of \$67.50.
- The Village DOES NOT pick up overflow garbage. Excess garbage generated due to the holidays must be disposed of by the renter or property owner. This can be done by spreading your overflow garbage over a couple of week's collection, asking a neighbor if they have room in their polycart, or by hauling the overflow garbage to the landfill.
- Wrapping paper is NOT recyclable. This must be placed in your regular garbage collection.

Winter Driving

- Remember to slow down and drive with extra caution during the winter season. Allow more time for your trips to school, work, and shopping.
- The Village will maintain the street pavement as best they can. This does not mean the pavement will be completely free of snow and ice.
- There will always be situations where snow and/or ice build-up will occur on our streets and intersections especially early in the morning or later in the evening when the sun sets, as temperatures drop.
- Allow extra room when following other vehicles, approach intersections with extra caution, and assume your vehicle will not stop as fast as it does on dry pavement.
- Remain at least 200 ft behind snow plows and spreaders.

Snow Removal

- Village ordinance 430-10 states that it is unlawful to shovel, blow, or plow snow onto or across Village streets or alleys. Citations will be issued to habitual offenders.
- Salt barrels placed at specific intersections are to be used for emergency use only. These salt barrels are not provided for residents for their own application. Salt for sidewalks and driveways should be purchased at local retail outlets.
- Corner lot owners are asked to keep a path open through the crosswalks, the Village crew will clear the remainder of snow as time permits.
- Anyone with a fire hydrant near his or her property is asked to help keep the snow cleared from around it. This will allow for quick response time if ever the fire department needs to access the hydrant.
- Snow must be cleared from the sidewalks within 24 hours after each snowfall. If ice builds up, it must be removed or treated with a melting agent. It is Village policy to address unshoveled sidewalks only when a complaint has been filed. Village officials do not go out looking for sidewalks that need shoveling. No written or verbal notice will be given to violators per ordinance 430-10.

- Once you are out, stay out
- Don't go back in for possessions or pets
- Notify the Fire Department if someone is missing or unaccounted for

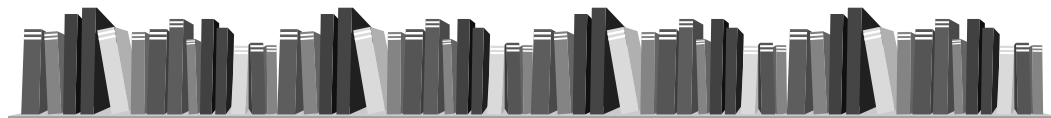
Reduce Chance of Cooking Fires

New Publishing Options for Authors at the Kimberly-Little Chute Public Library

Authors seeking to self-publish their work have more options than ever, for free, from the Kimberly-Little Chute Public Library. Tools offered by the library aid in all parts of production, from concept, to publication, to getting your work in the hands of readers.

Pressbooks can help you design your own books, newsletters, poetry, and any other written content in digital and print-ready formats. The online software is easy to use and produces professional-quality print-ready or eBook files.

Authors can submit their original eBook to the SELF-e program to have it showcased in the Indie Wisconsin Statewide Collection while retaining all rights to their work. This gives authors increased opportunity for their work to be discovered by readers all over the state, and with possible national exposure, too.

Readers can discover local authors work using the BiblioBoard Library app or website.

Pressbooks and SELF-e are accessible through infosoup.org under the heading Self Publishing Toolbox.

Mobile Printing Introduced at Kimberly-Little Chute Public Library

Let's face it, maintaining a printer isn't always fun and can be expensive. Kimberly – Little Chute Library would like to help make your life simpler with our new mobile printing solution. Patrons can now print remotely or in the library from smartphones, tablets and computers. Pick up printouts at the library of your choice during regular business hours.

Did you forget to pick up ink cartridges and need to print your Christmas letter in color? No problem, our Xerox printer can print in color or black and white. Prints on 8.5x11 paper cost \$.10 per page/side in black and white, and \$.25 per page/side for color.

Patrons can access the printer app from the website, www.kimlit.org. Links are located under the "Print From Home" heading. Jobs sent through the app will be available for pickup for 72 hours.

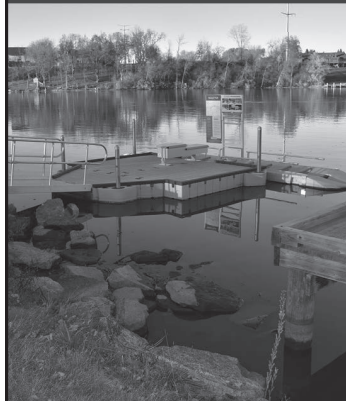

OVERNIGHT PARKING BAN

Per Village ordinance, vehicles are not permitted to park along Village streets from 2:00 AM to 6:00 AM, between December 1st and April 1st. Vehicle owners may request permission from the Fox Valley Metro Police Department to leave their vehicle parked on Village streets during this period. To request overnight parking permission, individuals should contact the overnight parking request line at (920) 788-7512 and follow the automated system.

NOW AVAILABLE - MEDICATION DROP BOX

Our department recently received a secure medication drop box which was obtained through a grant from CVS Pharmacies. The box is located in our lobby and is accessible during regular business hours. Items which can be disposed of include: Prescription (medications, ointments, and patches), Vitamins, Over the Counter Medications, and Pet Medications. Does not include: Sharps, Aerosol, or Inhalers, also no Liquids or Thermometers.

Please keep all medications in the original containers or a plastic bag – no loose pills.

WINTER FIRE HYDRANT MAINTENANCE

A clearly visible fire hydrant could save your home, or even your life. If a hydrant is buried in snow, firefighters could lose valuable time locating it. You can perform a valuable public service by taking responsibility for maintaining “your” hydrant during the Winter. We would like to offer the following suggestions:

- Know the location of your hydrant.
- Make sure it is shoveled clear after each snowfall (at least 3 feet all around).
- Adopt a hydrant and be proud to make it the best looking hydrant in your area.

SIDEWALK REPLACEMENT

The Village Board has an ongoing sidewalk rehabilitation program to provide safe walking surfaces for pedestrians. The primary concern is whether the sidewalk presents a hazardous or potentially hazardous condition to pedestrians, bicycles, infant stroller, etc. Appearance of the sidewalk has no bearing whatsoever on its replacement or acceptability. Such conditions as discoloring, minor cracks, checking, negative sloping (away from the curb), minor settling without displacement, etc. are not caused for replacement. Following is the list of criteria for replacement of sidewalk blocks:

- $\frac{3}{4}$ " vertical differential in sidewalk blocks.
- Settled out of vertical alignment (more than 1" per foot from normal grade).
- Having a crack $\frac{1}{2}$ " wide.
- Settlement in abutting cracks or blocks that trap water.
- Broken corners and or surface lacerations in which concrete is popped out and creates surface depressions causing a safety hazard (multiple cracks).
- Sidewalk that has protruding structures over 1" (trees, poles, etc.)
- Drop of edges

All sidewalks will be marked for replacement with the intent of pouring up to a structurally sound adjoining concrete block.

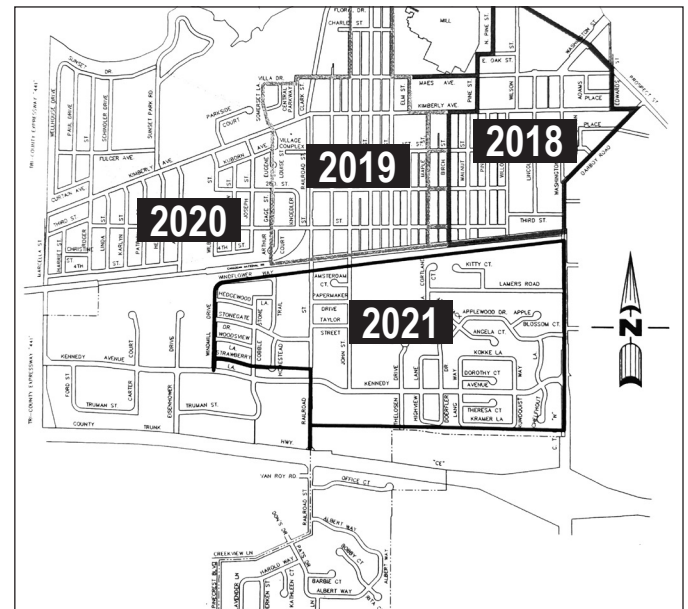
SIDEWALK REHABILITATION PROGRAM

2018 – Darboy Road to Birch Street

2019 – Birch Street to Gage Street – between the river and the tracks

2020 – Gage Street to Marcella Street – between the river and the tracks

2021 – Washington Street to Windmill Drive – south of the tracks



Due to the inability to secure a contractor to replace sidewalk in 2018, the Village of Kimberly will complete both 2018 and 2019 sidewalk rehabilitation areas as identified on the map, as well as for new homes in the Emons Acres subdivision where sidewalk has not yet been installed. Once all blocks are identified with a green dot, a letter providing further instruction will be mailed to property owners with marked sidewalk sections or planned sidewalk installation.
