#### **Registration for the Presidential Election**

PLEASE DO NOT WAIT until Election day. We expect long lines for registration for the Presidential Election. Allow at least one hour for registration on Election Day. Plan ahead and complete your registration in a few minutes prior to election day.

#### 2021 ELECTIONS

**February 16, 2021** – Spring Primary, if required to reduce the number of candidates on the Spring Ballot.

#### April 6, 2021 - Spring Election

The following municipal offices are to be elected.

<u>Village Trustee</u> (3) - 2 year term (incumbents: Lee Hammen; Tom Gaffney; and Peggy Weber)

Candidate paperwork for Village Trustee will be available for pick up in the Clerk's Office as of November 18, 2020. The first day to circulate nomination papers is December 1, 2020. The final day for filing nomination papers is 5:00 p.m., on Tuesday, January 5, 2021, in the office of the Village Clerk.

#### **Absentee Ballots**

Need to vote absentee? Absentee Ballot Applications can be found at <a href="www.myvote.wi.gov">www.myvote.wi.gov</a> or by emailing <a href="jmicke@vokimberly.org">jmicke@vokimberly.org</a>. You can stop in the Village Hall office to complete the application or call and one will be mailed to you. A copy of your photo ID must be included with your application for a ballot, if we do not have it on file already. Apply early to ensure your ballot is sent and returned in time to be counted on Election Day!

In office Absentee voting will be available the TWO WEEKS prior to the election.

The Monday before an election is **closed** for both absentee voting and registration.

#### **Voter Registration**

If you are a new voter or have moved or changed your name, you must register to vote. Update your voter registration at least 20 days before an election in order to be preprinted in the regular poll book. Complete the paperwork at the Village Clerk's Office or register online using <a href="www.myvote.wi.gov">www.myvote.wi.gov</a>. You will need proof of residency that states your current name and current address – WI license/ID, utility bill, bank statement or credit card statement, or government document works best. Call if you need more options.

# STREET DEPARTMENT

#### **Leaf Pickup**

Leaf pick up will begin around the second week in October and continue through November 20th, weather permitting. Place all leaves on the terrace for pickup.

- Rake leaves to the terrace, NOT INTO THE STREET.
- DO NOT put leaves in bags, leaves which are placed in bags or any container WILL NOT be picked up.
- DO NOT rake twigs or branches with the leaves. They will clog the vacuum.
- Please keep plastic and paper out of piles.

Please keep in mind when leaf pickup begins, the volume of leaves are minimal which means you may see the trucks canvas the town more often. Later when all the trees drop their leaves, usually overnight, the volume of leaves slows down pick up times and the trucks take longer to get through the Village. When leaf pick up is at its prime, you may only get picked up once in a two week period. Once the truck has been down your street it may take that long to return.

#### **Fall Leaf Collection**

In attempts to keep residents better informed of Leaf Collection progress, the Street Department will post regular progress and planned route updates, at least weekly on the Street Department Web Page. It is hoped this service will offer residents the ability to project when leaf collection equipment will arrive in your neighborhood.

Additionally, the Street Department has constructed a Yard Waste Drop-Off Site to provide residents the option to deposit leaves at this site.



#### 2021 Yard Waste Drop-Off Site Permits Now Available

Residents who have obtained the required \$5.00 annual permit may drop off grass trimmings, leaves, flower & vegetable garden waste, nuts, fruits, and small twigs and brush that are not larger than ½ inch diameter and 18 inches long. Larger brush is not accepted due to space limitations, but will still be collected with the Village's curb side brush collection service.

The Drop-Off Site is accessed by using the W. Maes Avenue entrance and is open 6:30 a.m. to 8 p.m. daily, including weekends and holidays.

This site may be used by village residents living in households that are serviced by the Village refuse collection program (households up to four dwellings.) The drop off site cannot be used for depositing waste generated by commercial lawn, landscape, or tree care businesses, by rental property owners except as identified in the rules, or other businesses.

Permits may be obtained at the Village Municipal Complex at 515 W. Kimberly Avenue or the Street Department at 426 W. Kimberly Avenue. Residents will need to complete the application and provide proof of residency with a current driver license or utility bill. Permits obtained in 2020 will be valid through December 31, 2021.

The Permit Application, Rules, and a Site Map are accessible at the Village's home web page using the NEW Yard Waste Site link in "Quick Links".

#### **Weekly Brush Pickup**

Brush which is longer than 18" and not more than 4" in diameter MUST be called in by 2:00 p.m. on WEDNESDAY for a Thursday pickup.

#### **Report A Concern & After Hours Messages**

The Street Department has two venues providing residents the ability to Report a Concern or leave a message after hours, such as reporting potholes, damaged street signs, and fallen trees or limbs. Residents may leave a voice message on the Street Department's phone, 920-788-7507, or may send email messages to streets@vokimberly.org. Residents are also encouraged to use these when requesting to be placed on the Brush Pick Up schedule or the Yard Waste Pick Up schedule. Please remember to submit these requests before 2 p.m. the day before the scheduled collection day, and always include your name, address, and phone number to better ensure timely service.

## STREET DEPARTMENT

# Garbage & Recycling Reminders for Winter and the Upcoming Holidays

- The days for Bulky, Non-Metal Collection were changed two year ago to Monday and Wednesday for the designated week each month. Please reference the 2020 and 2021 Garbage and Recycling Calendars for the collection dates for your address. This change was made to assist in providing adequate staffing throughout the week for other duties.
- Polycarts CANNOT be placed in the road or on top of snow piles
- The polycart MUST be placed at ground level either on the terrace or in the driveway. Polycarts which are placed in the road for pick up, during winter months, are subject to be plowed over and damaged. Replacement of damaged carts are the responsibility of the property owner at the cost of \$73.50.
- The Village DOES NOT pick up overflow garbage. Excess garbage generated due to the holidays must be disposed of by the renter or property owner. This can be done by spreading your overflow garbage over a couple of week's collection, asking a neighbor if they have room in their polycart, or by hauling the overflow garbage to the landfill.

#### **Snow Removal**

- Village ordinance 430-10 states that it is unlawful to shovel, blow, or plow snow onto or across Village streets or alleys. Citations will be issued to habitual offenders.
- Salt barrels placed at specific intersections are to be used for emergency use only. These salt barrels are not provided for residents for their own application. Salt for sidewalks and driveways should be purchased at local retail outlets.
- Corner lot owners are asked to keep a path open through the crosswalks, the Village crew will clear the remainder of snow as time permits.
- Anyone with a fire hydrant near his or her property is asked to help keep the snow cleared from around it. This will allow for quick response time if ever the fire department needs to access the hydrant.
- Snow must be cleared from the sidewalks within 24 hours after each snowfall. If ice builds up, it must be removed or treated with a melting agent. It is Village policy to address unshoveled sidewalks only when a complaint has been filed. Village officials do not go out looking for sidewalks that need shoveling. No written or verbal notice will be given to violators per ordinance 430-10. Failure to comply will result in sidewalks being cleared by the Village and billed at a rate of \$75.00 per hour, plus equipment usage. A minimum of one hour will be charged to clear sidewalks.



#### **Winter Driving**

- Remember to slow down and drive with extra caution during the winter season. Allow more time for your trips to school, work, and shopping.
- The Village will maintain the street pavement as best they can.
   This does not mean the pavement will be completely free of snow and ice.
- There will always be situations where snow and/or ice buildup will occur on our streets and intersections especially early in the morning or later in the evening when the sun sets, as temperatures drop.
- Allow extra room when following other vehicles, approach intersections with extra caution, and assume your vehicle will not stop as fast as it does on dry pavement.
- Remain at least 200 ft behind snow plows and spreaders.

#### **Sidewalk Replacement**

The Village Board has an ongoing sidewalk rehabilitation program to provide safe walking surfaces for pedestrians. The primary concern is whether the sidewalk presents a hazardous or potentially hazardous condition to pedestrians, bicycles, infant strollers, etc. Appearance of the sidewalk has no bearing whatsoever on its replacement or acceptability. Such conditions as discoloring, minor cracks, checking, negative sloping (away from the curb), minor settling without displacement, etc. are not causes for replacement. Following is the list of criteria for replacement of sidewalk blocks:

- ¾" vertical differential in sidewalk blocks.
- Settled out of vertical alignment (more than 1" per foot from normal grade).
- Having a crack ½" wide.
- Settlement in abutting cracks or blocks that trap water.
- Broken corners and or surface lacerations in which concrete is popped out and creates surface depressions causing a safety hazard (multiple cracks).
- Sidewalk that has protruding structures over 1" (trees, poles, etc.)
- Drop of edges

All sidewalks will be marked for replacement with the intent of pouring up to a structurally sound adjoining concrete block.

#### **Sidewalk Rehabilitation Program**

2021 – Welhouse Drive east up to Clark Street (not to include Clark Street) – between Kimberly Avenue and the River.

#### **Overnight Parking Ban**

Per village ordinance, from December 1st to April 1st, vehicles are not permitted to park along village streets between the hours of 2 a.m. and 6 a.m. Vehicle owners may request permission from the Fox Valley Metro Police Department to leave their vehicle parked on the village streets during this period. Requests need to be emailed to overnightparking@fvmpd.org and include the following information: date, registered owner's name, phone number, email address, license plate number, vehicle description, and address where the vehicle will be parked. Requests are limited per address and acceptance is dependent on weather conditions. Additional information on Winter Parking Restrictions can be found at www.fvmpd.org under the Overnight Parking tab.

#### **Metal Recycling Dumpster**

Many residents ask if they are allowed to drop metal items off at the metal dumpster located near the yard waste site. Well the answer is yes, with restrictions. The Village of Kimberly still offers curb side pickup if you do not have the means to haul your metal items, however a \$10.00 sticker is required for miscellaneous metal.

The dumpster is for depositing qualifying metals only. Materials not permitted in this dumpster include:

- Refrigerators, freezers, air conditioners, dehumidifiers and other appliances containing Freon or other refrigerants. Contact the Street Department at 788-7507 for disposal information.
- NO TIRES including bike tires.
- Non metal items.
- Items containing both metal and non-metal materials, contact the Street Department at 788-7507 for approval.

This dumpster is a service for the benefit of the community. The success and continuing operation of this site relies on all users following Village Board adopted policies.

Remember an annual permit is required to deposit yard waste, with no permit required to deposit waste oil or misc. metal. This site is monitored by security cameras and non-compliant use and dumping is subject to municipal fines.

#### **Waste Oil Site**

Watch for the new and improved Waste Oil Collection site. A NEW tank is ordered and when received, this service will be relocated within the yard waste site. No fee or permit needed to use this service.

### YARD WASTE 2021 RENEWAL PERMITS AVAILABLE NOW

Do you have a current Yard Waste Permit and would like to renew for 2021? Why wait, 2021 permits are available today.

Tired of raking your leaves only to have them blow back in your yard? Did you know with an annual Yard Waste Permit you can bring your leaves to the yard waste site from 6:30 a.m. till 8:00 p.m. 365 days a year.

#### **Winter Fire Safety Basics**

- Replace smoke detectors if they are older than 8 years
- Change batteries in your smoke detectors and carbon monoxide detectors
- Use flameless candles (they make wonderful Christmas presents)
- Change your furnace filter
- Discuss fire escape plans with your family

#### **Retention Pond Safety**

They say ice is never safe! This is especially true for retention ponds as the water flows change and the water comes from the warmer storm sewers. PLEASE STAY OFF OF THE PONDS!

#### Winter Fire Hydrant Maintenance

A clearly visible fire hydrant could save your home, or even your life. If a hydrant is buried in snow, firefighters could lose valuable time locating it. You can perform a valuable public service by taking responsibility for maintaining "your" hydrant during the Winter. We would like to offer the following suggestions:

- Know the location of your hydrant.
- Make sure it is shoveled clear after each snowfall (at least 3 feet all
- Adopt a hydrant and be proud to make it the best looking hydrant in your area.

#### **Crossing Guards**

The Fox Valley Metro Police Department is currently seeking Crossing Guards and Crossing Guard Substitutes. This is routine outdoor work performed on pre-scheduled and varied shifts in the Villages of Kimberly and Little Chute. Major responsibilities include caring for the safety of children at street crossings. Applicants need to pass the background check and be at least 18 years of age with a high school diploma or equivalent. They must also possess a valid Wisconsin driver's license or the ability to meet the transportation requirements of the position. The starting wage for this position is \$14.48/hr. This fall we received a grant for improving access to the internet. We now have circulating laptops and an outdoor Wi-Fi access point that will provide a strong signal for the internet in our parking lot. Digital collections have been expanded to allow you to safely read, watch, and listen anytime safely from your own home if you have access to the internet. If you do not have access, your library is circulating wifi hotspots.

During the pandemic, our services have been modified; our goal is to continue to offer curbside service during library hours in addition to our always available online resources. Our team is striving to provide additional services and dependent on local health indicators, we may have opportunity for you to use our computers, fax, and photocopy services as a drop-in program. We expect to offer appointments for browsing this fall and winter. We do currently require all children who have not completed 8th grade or are under the age of 15 to be accompanied by a responsible adult in the library.

#### A New Kind of Book Club

The pandemic made us rethink library programs to connect with readers and offer a sense of community. Shortly after Governor Tony Ever's Safer at Home orders were in effect last spring, Quaranstories was introduced.

Quaranstories is a short story club in which participants read one

pandemic," said Julie Conrad, Quaranstories moderator. "After deciding to go ahead with the idea, I thought it would be fun to choose a short story by a contemporary author one week and a short story by a classic author the next week. This has both introduced the group to many new authors and has had them revisiting short stories from the past."

The group has discussed short stories by Herman Melville, Mark Twain, Stephen King, and Isabel Allende.

"The classics have been challenging in that the use of language has changed over the years and we are often looking into what the old expressions meant," said Julie. "It has been a great alternative to a traditional book club. We spend 30 minutes discussing each story in the one hour bi-weekly Zoom meeting. Short stories often leave a lot to the imagination, so it is always interesting to hear the different interpretations of the stories."

A Zoom account is not necessary to participate. Those interested can contact Julie at jconrad@kimlit.org to get an invitation.

If someone enjoys reading the stories but is not interested in the Zoom discussion, that is okay too, Julie added. "I encourage the participants to send me a few comments about the stories so I can publish them on the Facebook event - no spoilers allowed! I also encourage them to suggest short stories for future discussions. It has been a really enjoyable way to engage during the pandemic and I feel like it supports our mission of inspiring and supporting lifelong learning and the love of reading."



# 2020 A Year of Progress!

Coming to the riverfront late fall of 2020 – public access along Papermill Run. The Village staff has worked diligently throughout the construction season of 2020 to plan and create a connection along Papermill Run from Sidney Street to Wilson Street. During the month of October, the corridor will be paved with a temporary asphalt surface. The surface will provide for vehicle and pedestrian access along Papermill Run. The intersection of Papermill Run and Red/White Cedar Parkway will also be open.

Please drive the area with caution, be mindful of the pedestrian traffic and respectful of our valued sidewalk superintendents! The Village remains committed to fulfilling the desires of The Cedars Visioning sessions and working with developers to transform the riverfront. We hope each year brings exciting opportunities and further access to the area for our residents and the surrounding greater Fox Cities community.

As a reminder, the Village has been working with the Kimberly Community Development Authority and the Economic Development Organization in generating ideas and concepts to create a cohesive redevelopment theme to introduce the riverfront and tie into the existing downtown corridor. The Village welcomes the feedback of these groups, organizations and business owners. Creating concepts and amenities that are in-tune with the desires of the Village are important. The meetings of the Community Development Authority and Economic Development Organization, like all Board and Committee meetings, are open to the public.
