REGULAR MEETING OF THE KIMBERLY VILLAGE BOARD MINUTES May 16, 2022

Trustee Trentalge moved, Trustee Hammen seconded the motion to approve the Agreement to Participate in the Outagamie County-wide All Hazard Mitigation Plan.

There was no unfinished business.

A Village of Kimberly resident voiced her concerns about overflow parking at Sunset Park. She discussed the many cars that are parked on the grassy areas, when there are many open spaces in various parking lots within the park. She also had concerns regarding speeding issues and parking violations. President Kuen appreciated her input and would be speaking with Park Director Femal and the Street Department about placement of signage within the park.

Trustee Hammen moved, Gaffney seconded the motion to move into Closed Session per State Statute 19.85 (1) (c) to consider employment, promotion, compensation, or performance evaluation data of any public employee or conducting other specified public business whenever competitive or bargaining reasons require a closed session. *Personnel Matters*. The motion carried by a unanimous vote and the Board adjourned at 6:09 p.m.
