

Writing the "spring" article nearing the end of January seems too optimistic here in snowy and about to turn bitter cold, yet lends itself to looking ahead to warmer days and the rebirth of vegetation which enhances the beauty of our community.

I am hopeful that this finds you well and that over the winter months you may have enjoyed a visit to the ice skating rink or took part in one of the many programs offered through the library. Perhaps you visited the sled hill or meandered the trails through Sunset Park. I know that many of you have journeyed to the east end of the river front as I have fielded numerous inquiries as to the removal of trees, positioning of portable restroom facilities and generally "what's happening?"

Activity on the northeast end of the village is preparing for the next installment of development where the trailers have been parked and where the big blue building used to operate. We are busy installing water and sewer infrastructure ahead of the ground breaking for unique housing. I am hopeful that by the time this reaches you the developer will have revealed their plans. As of this writing, we have seen preliminary plans and have a developer's agreement to build east of Wilson Street toward the community bridge. We are excited with the developer's vision of building our living space in a very community minded manner.

Working in conjunction with this development will be the transformation of the old Shopko building to a vibrant Festival Foods which is targeted to open in the fall of this year. The clearing of trees to allow for beautiful river views mirrors what has been done across the river as well as with the development on the west end of the former mill property. As the development takes shape you will see beautified landscaping and a newly constructed river trail for walking and biking. We will also be building a detention pond as we continue to work in alignment with DNR directives in removing solids from storm water before they reach the treasured Fox River. This pond is designed to accentuate the natural beauty of the river and surrounding area.

As spring arrives and the buds begin to pop, the tulips and other perennials bloom, the village crew will be preparing for annual street maintenance with crack filling, concrete panel replacements and reconstruction of aging roads as we follow our capital improvement plans which are intended to affordably maintain the streets in a methodical manner. With Sunset Drive on the schedule for 2023, we are anxious to see where bids come in for the work. I say anxious because of the significant increases that we are seeing in this inflationary time. Street and sidewalk work will be communicated in advance and the village team and elected officials will be available to answer questions and help

coordinate as projects are finalized. I encourage you to engage when public hearings are announced. These meetings prove to be highly beneficial in our effort to work cooperatively with residents on these types of projects.

The Recreation Department has a robust plan of activities for the coming summer months and springtime is the right time to check these out and plan to participate. The library will continue with a wide variety of things to explore for people of all ages and I encourage you to check them out as well.

My final thought this issue centers on safety. We are blessed here in Kimberly with the services of the Fox Valley Metro Police Department and the volunteer Fire and EMR team. The Fox Valley Metro lives out its commitment to protect and serve 24 hours a day, 7 days a week. The reality is that most of us never really know what they are "up to" and that is a very good thing! The number of calls they respond to grows every year yet the spotlight does not shine upon them and that is due to their organization, training and professionalism. Acts of kindness and heroism are a part of what they do and we are grateful. The FVMPD team is truly engaged with our community and works to give back through various fundraising activities each year and they do so quietly and purposefully—professionals, and we are grateful. The Fire and EMR team drills weekly and responds at all hours of the day and they serve in a volunteer capacity; how blessed are we? This group continues to look for dedicated individuals to join in their effort. I encourage anyone to explore the opportunity to serve. I know the training will be top notch and the experience will be one of friendship building that will last a lifetime. As I read newspapers and watch local news, I am concerned with the what seems to be never ending/ever growing activity which does not align with our values of "community"—that being the treating of one another with dignity and respect. I believe that the strength of maintaining our sense of community is hinged on the public safety leadership and presence throughout the community. I am grateful for their collective leadership and presence as they work with dedication in maintaining Kimberly as a great place to live, learn, work and play.

**STREET PROJECT** Sunset Drive - Full reconstruct: Street pavement, sanitary sewer & laterals, storm sewer, water main.

**SIDEWALKS** to include these streets: S John St. (south of railroad tracks), Thelosen Dr., Highview Ln., Doerfler Dr., and W Kennedy Ave. between S John St. and Doerfler Dr.

#### Free Spring Tire Pick Up

Wednesday, April 19th - Entire Village

This free tire pick up has been authorized by Outagamie County and the Village will not pick up tires at any other time. There is a limit of 4 tires per household, rims are acceptable, and tires cannot be larger than 18" passenger vehicle tires. (No business generated tires)

#### **Spring Yard Waste Clean Up**

Curbside yard waste will be picked up on May 8th, for residents north of tracks and May 15th for residents south of tracks. Garden debris, flowers, lawn edgings, and shrub trimmings (not to exceed 18") in length will be picked up. Material MUST BE PLACED IN BROWN PAPER LAWN AND YARD WASTE

**BAGS** and not to exceed 50 lbs. Yard waste stickers are <u>NOT</u> required during the spring yard waste clean up. *No Grass Clippings to* 

yard waste clean up. No Grass Clippings to include thatching from your lawn!

Branches longer than 18" require a special pickup on Thursdays. Residents must call 788-7507 or email streets@vokimberly.org prior to 3:00 PM on Wednesday to schedule a Thursday brush pickup.

The Village also offers its residents a yard waste site which can be accessed 365 days a year between 6 am and 8 pm. An annual permit is required to use this site. The site is monitored by security cameras. Users found violating the rules are subject to applicable enforcement action. For more information visit the Village website at www.vokimberly.org.

### Kimberly Water Department Semi Annual Hydrant Flushing

The Kimberly Water Department will be cleaning and flushing water mains from 7:00 am to 3:00 pm beginning **April 17th – 20th and April 24th – April 27th.** The flushing will remove most of the natural minerals that have settled in the mains such as iron, a harmless-reddish brown mineral that does discolor the water.

If you observe Water Utility Personnel working in your area, refrain from using water or use as little as possible for 45 minutes to ensure that the water has settled in the mains. This will also help prevent any iron from being drawn into your water piping system.

If you do find that your water has become discolored, refrain from using it for an additional 30 minutes. Then draw off the remaining discolored water through the **COLD WATER FAUCET ONLY.** 

Your cooperation during this flushing procedure will benefit all water customers.

### **Spring Election April 4, 2023**

The spring election will be held Tuesday, April 4, 2023. Voters can view a full listing of races and candidates at myvote.wi.gov.

#### **Absentee voting**

If you are unable to get to your polling place on Election Day, you can vote by Absentee Ballot (mail or in-person).

#### **Absentee voting by mail:**

Applications can be completed online at myvotewi.gov. Applications may also be requested by emailing jweyenberg@ vokimberlywi.gov, calling 788-7500, or stopping in the Clerk's office. A copy of your photo ID must be included with your application for a ballot unless it is already on file. Voters may request to vote by mail for a specific election or all elections within the current calendar year. Indefinitely Confined voters (confined because of age, illness, infirmity or disability) may request absentee ballots be mailed to them indefinitely.

#### **Absentee voting in-person:**

In-person absentee voting will be held March 21st-31st. There is no absentee voting hours on the weekends or the Monday before the election.

#### **Voter registration**

If you are a new voter, have moved, or changed your name you must register to vote. Village of Kimberly residents may register to vote in the Clerk's office before 5:00 p.m. the Friday before Election Day or by mail 20 days prior to Election Day.

On Election Day, residents may register to vote at the polling place. Be sure to provide proper proof of residence. Polling places are open on Election Day from 7:00 a.m.- 8:00 p.m.

#### **Kimberly Public Library is Fine Free!**

Here are some answers to frequently asked questions about being fine-free.

#### What does it mean to be fine free?

It means that the library will not charge a daily fine for items returned past their due date.

#### Are all items fine free?

Kimberly Public Library's policy applies to all items borrowed from the Kimberly Library.

#### I have overdue fines on my account. Do I need to pay those?

You are not required to pay overdue fines that existed before the policy was adopted, but you can if you want to. The library can accept voluntary donations at any time. If you have existing fees for lost or damaged items or other miscellaneous fees, those fees are still owed to the library. We are only removing fines for overdue items.

#### Why is the library going fine free?

We understand that everyone has a lot to keep track of and would like to remove the financial penalty of returning your items late. We want to be sure everyone has access to the library and do not want fines to be a barrier. Financially, fines are less than 1.0% of our annual budget, and collecting fines requires staff time, which costs money.

#### What if an item still isn't returned after it is overdue?

When the item is 28 days overdue, we'll bill you for the cost of the item. Once an item is returned in good condition, the bill will be removed. If the item is overdue more than 90 days, it will

be sent to collections. Once an item is sent to collections, the replacement fee will not be forgiven if the item is returned.

### Can I renew an item before the due date or after it is overdue?

All of our renewal policies have stayed the same. You can still renew items as before and are encouraged to do so you don't accidentally end up being billed for the item after 28 days overdue. Renewals also give the library an accurate accounting of what materials are circulating.

### Will the lack of fines impact the availability of popular items? Studies have shown that removal of fines does not lead to

an increase in materials not being returned on time. We are optimistic that library users will be considerate of other users on the holds list and return their items in a timely manner.

### What if I use my InfoSoup library card to check out an item at another library in the system?

If you check out an item at a library that does charge fines, you're still responsible for paying any fines to that lending library.

#### What about old bills for lost or damaged items?

We cannot waive bills on lost or damaged items. We are only removing fines for items returned past the due date.

#### My card is still blocked. Why can't I use it?

There are many reasons why your card may be showing as blocked or barred. The most common reasons include you have fees over \$5 for lost or damaged items. Please contact Kimberly Public Library for assistance.

#### **Firefighters for Fireworks Fundraiser**

The annual cornhole tournament is planned for March 18th at Tanners. This is our major fundraiser for the annual fireworks held on July 3rd at Sunset Park. We would love to have you join us! Registration starts at 1:00 pm and matches begin at 3 pm.

#### Want to be "Someone"?

We have 31 volunteers that provide Fire and EMR service to approximately 7,000 Kimberly residents. When someone needs help, we all need "someone" to respond. If interested please apply, interviews are being planned in March for firefighters and EMR responders. You can serve in either, or both roles.

#### **Dryer Safety**

- Make sure the air exhaust vent pipe on the outside of your home is free from snow and is not restricted and that the outdoor vent flap will open when the dryer is in operation.
- Move items that can burn such as boxes, cleaning supplies and clothing away from the dryer.
- Clothes that come in contact with flammable substances

like gasoline, paint thinner, or similar solvents should be laid outside to dry, then can be washed and dried as usual.

#### **River Safety**

As we approach spring the river currents become stronger due to the damns being open to move the spring thaw. Use caution when kayaking or canoeing on the Fox River. These currents can be very dangerous for even experienced paddlers.

#### **Spring Yard Waste**

Village Ordinance 270-8 prohibits burning of leaves, brush, weeds, vegetative debris, and stumps. Purchase a yard waste permit for year-round disposal or follow the Village of Kimberly's Garbage and Recycling Calendar for curbside collection dates.

#### **Spring Pond Burns**

As recommended by our engineering firm, we plan to do prescribed burns at Memorial, Sunset Park, Emons, and Cedars West ponds this spring. The weather and availably of firefighters are huge factors when doing prescribed burns. Hopefully mother nature is on our side, and we can complete all four ponds by the April 15th deadline.

#### **DOG LICENSES -**

In accordance with State Statutes and Village Ordinance, dogs must be licensed annually, and must be done so within 30 days of residency in the Village. 2023 dog licenses are now available at the Village Complex. There is a mail-in application below for your convenience. When applying for a dog license, owners must present the current rabies vaccination certificate. Every dog 5 months or older must have a current Rabies shot. Neutered and Spayed Licenses are \$7.00, intact Dog Licenses are \$12.00. Failure to license your dog may result in a \$124.00 citation per dog, issued by FVMPD. If you no longer have your dog, please contact the office so we may update our records.

Licensed dogs have an opportunity to participate in Bark at the Beach and Pooch Patrol. Please call the Park and Recreation Department at (920) 788-7507 for more information.




