

### As the Frost Goes Out, The Buildings Will Go Up!

Hello everyone. I hope this finds you well and anxious to exit the winter season and enjoy the rebirth of tulips, the budding of trees and the preparation for the next seven months of lawn care. With spring around the corner, we are excited for construction to begin with several projects throughout the community.

As you have likely noticed, demolition and refurbishing of the future Festival Foods site has been under way for several months and we anticipate things ramping up even more as they target a fall opening for which we are mighty eager. Behind the new Festival Foods you will see the first residential properties emerge along Wilson Street as the first phase of Blue at the Trail gets underway. Last fall, the village work of coordinating road and utility installation was completed and in January the Plan Commission reviewed the first proposed buildings and shared their enthusiastic approval.

Work will accelerate with the demolition and rebuilding

of the Street and Parks Department building. The team vacated the building in early February to allow for the start of demolition as the project gets moving. I mentioned in my last Kimtalk article that we would keep you posted on this major reinvestment in our community. The project has been a work in progress for more than a year before any shovels reached the site. Careful planning was done by our staff in concert with architectural firm SEH to insure that the 70-year-old building being replaced is built to serve the needs of the community for an additional 75 years. I assure you that the discussions centered on cost and balancing the "want to haves" with the "need to haves" were robust and thoughtful. As I write, we are in the process of gathering bids for the project. While we know that this project will cost

near 14.5 million, we are cautiously optimistic in the bid process and eager to select a general

contractor that we will work closely with in driving out cost wherever possible, creating a solid and attractive facility which improves safety, extends the life of our equipment, and provides a much-needed improvement in the workspace for our valued team members. We will be active on Facebook with progress and intend to update along the way in this newsletter forum as well.

Oh, and yes, of course, springtime will generate the growth of orange barrels as street, sewer, and water service work will be underway. Please watch for notices inviting those involved in this year's projects to public hearings ahead of any work in your neighborhoods. Welhouse Drive will receive updated utilities and pavement. Trail construction will be completed on the south side of Kennedy Avenue and west side of Marcella Street from Cobblestone Lane to Kimberly Avenue. Mini storm will be installed on the south side of W. Fourth Street from Anne Street to Marcella Street and N. Sidney Street from Kimberly Avenue to the north end.

Yes, there is always optimism as springtime graces the village. A time of new growth and a time to interact with others, to enjoy the amenities available in our beautiful parks, and to consider participation in recreation programs. Try pickleball at Verhagen Park, do some learning through library offerings, sit quietly along the river or by one of our nature friendly ponds. Yes, let the allergies kick in as we rediscover why Kimberly remains a great place to live, learn, work and play.

**STREET PROJECT** Welhouse Drive – full reconstruct to include street pavement, sanitary sewer and laterals, storm sewer and water main.

**MINI STORM** installed on the south side of W. Fourth Street from Anne Street to Marcella Street and N. Sidney Street from Kimberly Avenue to the north end.

<u>MULTI MODEL TRAIL</u> Kennedy Avenue Trail south side of Kennedy Avenue and west side of Marcella Street from Cobblestone Lane to W. Kimberly Avenue.



# Beginning In 2024 –Fee ImplementedFor Tire Pick Up

Due to changes from Outagamie County, tire pick up is no longer free. All tires beginning with the Wednesday, April 17th collection will require payment of \$15.00 per tire. Tires cannot be larger than 18" passenger tires and rims are acceptable. NO business generated tires are accepted. Payment can be made in person at the Village Complex or by calling 788-7507. When paying with debit/credit card, a processing fee will be applied.

### **Spring Yard Waste Clean Up**

Curbside yard waste will be picked up on May 6th for residents north of tracks and May 13th for residents south of tracks. Garden debris, flowers, lawn edgings, and shrub trimmings (not to exceed 18" in length) will be picked up. Material MUST BE PLACED IN BROWN PAPER LAWN AND YARD WASTE BAGS and not to exceed 50 lbs. Yard waste stickers are NOT required during the spring yard waste clean up. No Grass Clippings to include thatching from your lawn!

Branches longer than 18" require a special pickup on Thursdays. Residents must call 788-7507 or email streets@vokimberlywi.gov prior to 3:00 PM on Wednesday to schedule a Thursday brush pickup.

The Village also offers its residents a yard waste site which can be accessed 365 days a year between 6 am and 8 pm. An annual permit is required to use this site. The site is monitored by security cameras. Users found violating the rules are subject to applicable enforcement action. For more information visit the Village website at www.vokimberly.org.

# **Kimberly Water Department Semi Annual Hydrant Flushing**


The Kimberly Water Department will be cleaning and flushing water mains from 7:00 am to 3:00 pm beginning **April 15th – 18th and April 22nd – April 25th.** The flushing will remove most of the natural minerals that have settled in the mains such as iron, a harmless-reddish brown mineral that does discolor the water.

If you observe Water Utility Personnel working in your area, refrain from using water or use as little as possible for 45 minutes to ensure that the water has settled in the mains. This will also help prevent any iron from being drawn into your water piping system.

If you do find that your water has become discolored, refrain from using it for an additional 30 minutes. Then draw off the remaining discolored water through the **COLD WATER FAUCET ONLY.** 

Your cooperation during this flushing procedure will benefit all water customers.

# There is no primary election needed on February 20, 2024

The 2024 Spring & Presidential Preference election will be held from 7:00am to 8:00pm on April 2, 2024. The polling place for all voters on Election Day is the Evergreen Room located at the Municipal Complex, 515 W. Kimberly Ave. Voters can view a full listing of races and candidates at myvote.wi.gov.

You can request an absentee ballot by mail by completing an application online at myvote.wi.gov. You can vote an absentee ballot in-person at our office during the following dates and times: March 19-March 29 (weekdays only, no Saturday or Sunday hours) from 8:00am to 4:00pm

If you are a new voter or if you have moved or changed your name since you last voted, you must register. Village of Kimberly residents may register to vote in the Clerk's office before 5:00pm the Friday before an election or by mail 20 days prior to Election Day. Voters may also register at the polling place. Be sure to bring proper proof of residency.

### **Curious About Badger Books?**

Starting with the April election, the Village will use Badger Books which are electronic poll books. You will no longer be asked to sign a paper poll book and will now check-in and sign your name at any of our 7 stations. To help answer any questions our voters may have, we are hosting a Badger Book Open House on Monday, March 11th from 4:00pm-6:30pm in the Evergreen Room. This is an informal opportunity for all voters to stop by to get familiar with the changes. We will have election officials available to demonstrate the check-in process and explain how it will work on Election Day.

### What's Happening at the Library?

Kimberly Public Library partners with other Fox City libraries to host Fox Cities Book Festival every year! The purpose of the Fox Cities Reads is to select an author and title that encourages people in our community to read, think, talk, listen and grow together. The Fox Cities Community Read is organized by the Fox Cities Book Festival in partnership with Appleton Public Library, Kaukauna Public Library, Kimberly Public Library, Little Chute Public Library, Menasha Public Library and Neenah Public Library.

*Infinite Country* by Patricia Engel is the 18th selection for Fox Cities Reads. It tells the story of a Colombian family's journey through immigration and their struggles to define home and maintain family connections. We encourage you to read the book with your community and join us for an event with the author. Author, Patricia Engel, was born to

Colombian parents and has won several literary awards for her novels and short stories.

Fox Cities Book Festival is one of 62 organizations nationwide selected to receive a 2023-2024 NEA Big Read grant in the amount of \$20,000. An initiative of the National Endowment for the Arts in partnership with Arts Midwest, the NEA Big Read broadens our understanding of our world, our communities, and ourselves through the power of a shared reading experience.

Fox Cities Book Festival planners are taking themes off the page and using creative programming to navigate difficult topics, explore new perspectives, and strengthen bonds between neighbors. A traveling exhibit from the Wisconsin Humanities Council just completed its stop in Kimberly, but it can still be viewed at Kaukauna Library during the month of February and Menasha in March. Book discussions will pop up throughout the Fox Cities this spring. In February, people are invited to explore Latino culture through an art experience at Trout Art Museum hosted by local Latino artist, Irineo Medina. ### **Outdoor and Refuse Burning**

Village ordinance 270-8 (B) Outdoor and Refuse Burning states: General prohibition on outdoor burning and refuse burning. Open burning, outdoor burning and refuse burning is prohibited in the Village of Kimberly unless the burning is specifically permitted by this section. This includes burning yard waste in the spring.

### **Dog Licenses**

In accordance with State Statutes and Village Ordinance, dogs must be licensed annually, and must be done so within 30 days of residency in the Village. 2024 dog licenses are now available at the Village Complex. When applying for a dog license, owners must present the current rabies vaccination certificate. Every dog 5 months or older must have a current Rabies shot. Neutered and Spayed Licenses are \$7.00, intact Dog Licenses are \$12.00. Failure to license your dog may result in a \$124.00 citation per dog, issued by FVMPD. Late fee applied after March 31st.

### **Reminder Of Ordinaces In Place For Dog Owners**

Village Ordinance 180-6 C. All dogs, cats or other domestic animals shall be kept on a leash no longer than eight feet at all times when off the premises of its owner.

Village Ordinance 180-10 Animal feces – The owner or person in charge of any dog, cat, or other animal shall not permit solid fecal matter of such animal to deposit on any street, alley or other public or private property unless such matter is immediately removed therefrom by said owner or person in charge.

#### **Storm Water Fee**

- 1. What is the purpose of the Storm Water Fee? The purpose of the storm water fee is to construct the storm water utility system infrastructure within the Village.
- 2. How is the Storm Water Fee calculated? The storm water fee is an amount multiplied by the equivalent runoff units (ERUs). The ERU on a property is determined by ordinance and the Village Engineer. A typical single family residential property is 1 ERU.
- 3. Why are ERUs used to calculate the fee? ERUs are a measure of impervious area on a property hard surfaces such as roof tops, driveways, and parking lots. The impervious surface contributes to the amount of storm water runoff from a property. The greater the runoff, the greater the need to manage the water through the storm water pipes and pond systems.
- 4. What is the 2024 Storm Water Fee? The Storm Water Fee is \$126.24 per ERU per year.
- 5. When was the last increase in the Storm Water Fee? Before the 2024 increase of 1%, the annual fee was adjusted on January 1, 2021, when it was increased for the first time since 2007 from \$110.00 to \$125.00.
- 6. Will this rate be adjusted every year? Storm water expenditures will be closely monitored against storm water fee revenues. In the future, the Village Board will determine if the rate needs to be adjusted.
- 7. How is the Storm Water Fee billed? The fee is included in the quarterly installments on the water utility bill.
- 8. Does the fee increase cover special assessments for mini-storm lateral construction or replacements? No, the Storm Water Fee does not eliminate special assessments for mini-storm lateral construction or replacement.
